#### **1. DEFINTIONS**

For the purposes of this Privacy Policy:

• Account means a unique account created for You to access our Service or parts of our Service.

- Affiliate means an entity that controls, is controlled by or is under common control with a party, where "control" means ownership of 50% or more of the shares, equity interest or other Application means the software program provided by the Company downloaded by You on any electronic device, named Company

- **Country** refers to: United States
